### **AUDIT REPORT (Amber Klausmeyer)**

The 2015-2016 Annual Audit shows that all funds are solidly in the black and the District is in sound financial shape. The audit showed no findings or noncompliant areas - signifying finances are fiscally sound. All funds have a positive balance and strong management controls are in place.

# **BUSINESS REPORT (Dennis Jurek)**

- Referencing the Budget Board Report of YTD Revenues & Expenditures, both state and local revenues are on target. The district has realized 20.18% of our projected revenue for Fund 199 compared to 23.69% last year.
- We have expended 15.60% of Fund 199 compared to 15.67% last year.
- Mr. Jurek reviewed the revenues and expenditures report regarding Food Service (Fund 240) and I&S (Fund 599). Expenditures for Food Service and I&S funds are under budget.
- Cash and Investments Report update was given.

#### **SUPERINTENDENT'S REPORT (Mike Coker)**

- Enrollment is 2233 compared to 2215(+18) at this same point last year.
- The Thanksgiving Holidays will begin November 21<sup>st</sup> through the 25<sup>th</sup>. Classes will resume on Monday, November 28<sup>th</sup>.
- Christmas Holidays will begin December 16<sup>th</sup> with a noon early release and classes will resume Tuesday, January 3<sup>rd</sup>.
- The next scheduled board meeting is Thursday, January 19<sup>th</sup>. We do not have a December Board meeting.
